Breda City Council Minutes May 13, 2024 City Hall

Mayor Dan Snyder called the meeting of the Breda City council to order at 5:30pm with Samantha Pietig, Kayla Tiefenthaler, Jeff Riesberg, Bob Boeckman and Chris Uhlenkamp present at City Hall. Bob Boeckman was absent. Motion by Pietig, seconded by Riesberg to approve the agenda. Motion carried. Moton by Riesberg, seconded by Uhlenkamp to approve the consent agenda which included the minutes of the April 15, 2024 meetings, claims, and payroll. Motion Carried.

Fire Department report was heard. Fire department's annual golf outing fundraiser is scheduled for July 13, 2024. A progress report was heard from the Public Works department. Public works reported storm drain repairs need to be made at the corner of 2nd and Maple as the storm drain is broken there on second 2nd is damaging the asphalt. Public Works stated that the Tiefenthaler addition on the east side of town is having water pressure fluctuation problems and requests possibly getting an engineer out to perform a water study. Motion to approve hiring Snyder and Associates for the water study by Uhlenkamp and seconded by Tiefenthaler. Building permits were reviewed for 302 Oak St, 106 S. 5th St, and 108 N. 3rd St. Motion by Pietig, seconded by Tiefenthaler to approve. Motion carried.

Mayor Snyder opened the public hearing for sale of proper lot 9 and 10, Breda Development 1 addition. City clerk receiving no written or oral comments. No public persons present. Motion to close public hearing by Pietig, seconded by Tiefenthaler. Ayes: Pietig, Tiefenthaler, and Riesberg. Boeckman absent. Uhlenkamp abstained. Council considered Resolution 2024-05-01 for quit claim deed for lot 9 and 10, Breda Development 1 addition. Motion to approve Tiefenthaler, seconded by Riesberg. Ayes: Pietig, Tiefenthaler, Riesberg. Absent Boeckman. Abstain Uhlenkamp.

The council discussed the pool family night and food trucks. It had been brought to the attention of City Clerk Rhonda Martin that the Breda Recreation League was requesting the city does not have food trucks in for family fun nights as they could be a case of loss revenue for the Recreation League. Council voted to keep the food trucks at the pool. Motion to approve by Pietig, seconded by Uhlenkamp to keep the trucks. Too late to cancel with such short notice. Ayes Pietig, Tiefenthaler, Uhlenkamp. Absent Boeckman. Naye Riesberg. Group swimming lessons will be scheduled June 10-14, 2024. Discussion was had about the park bathrooms. As of now the bathrooms in the park will be left unlocked. However, if any vandalism happens, the bathrooms will be locked again. Council reviewed the resolution for setting salaries for fiscal year 2025. Council decided to table discussion until the following meeting. Tax abetment request was received for 207 Daryl St. Council reviewed. Motion to approve by Tiefenthaler, seconded by Uhlenkamp. Ayes, Tiefenthaler, Pietig, Riesberg, and Uhlenkamp. Absent Boeckman. City Clerk, Rhonda Martin reported on the meeting that was held the Saturday before with the pool employees. It has been determined that opening day for the pool with be May 25th, 2024. City clerk advised council that the Breda Community club has stated that they will not be making or organizing building of any parade floats for any of the surrounding cities celebration. As of this time, council agreed that the city will not be e also.
