

Breda City Council Minutes
September 9th, 2024 City Hall

Mayor Dan Snyder called the meeting to order at 6:00 PM with Samantha Pietig, Kayla Tiefenthaler, Jeff Riesberg and Chris Uhlenkamp present. Bob Boeckman was absent. Motion by Pietig, seconded by Uhlenkamp to approve the agenda. Motion Carried. Motion by Uhlenkamp, seconded by Tiefenthaler to approve the consent agenda containing the minutes of the August 12th meeting, financial reports, claims and payroll. Motion Carried.

Fire Chief Dan Wiskus was absent. City Clerk Rhonda Martin advised Wiskus had only one item for the meeting. The department would like to add Latham Hedeem as a new volunteer. Motion to approve by Uhlenkamp, seconded by Pietig. Motion carried.

County Supervisor District 2 Mike Andersen was present. Council discussed with Andersen 2 roads coming through town and out of town that the city would like to have repaired. As of this time per Anderson, those 2 roads are not part of the county's 5 year plan.

Public works report was heard.

Permit for 405 Artz St. was reviewed. Motion to approve Uhlenkamp, seconded by Riesberg. Motion Carried. Absent Boeckman.

Mayor Snyder opened public hearing for the Proposed Budget Amendment for FY 2025. No one from the public was present. City Clerk Martin reported not receiving any written or oral comments. Motion by Uhlenkamp, seconded by Pietig to close the meeting. Ayes Pietig, Riesberg, Uhlenkamp, and Tiefenthaler. Boeckman absent.

Council consider resolution 2024-0901 to amend the budget. adopting the FY 2025 Budget. Motion to approve by Uhlenkamp, seconded by Tiefenthaler, Ayes Pietig, Riesberg, Uhlenkamp, and Tiefenthaler. Boeckman absent.

Marsha Stork was present on behalf of the Legion Auxiliary. The Auxiliary will be placing a new 50' flag pole in the park. Stork requested that the city pay for lighting for the flagpole. Motion by Riesberg, seconded by Tiefenthaler to pay up to \$600 for lighting for the flagpole. Ayes: Pietig, Uhlenkamp, Riesberg, Tiefenthaler. Absent Boeckman.

Council discussed finding from the water study report conducted by Snyder and Associates. Council agreed to table discussion until the October meeting when a representative for the engineer firm would be present for questions.

Brad Agan was present to request a streetlight be installed in the alley behind his house. Motion to approve by Uhlenkamp, seconded by Tiefenthaler. Ayes Pietig, Riesberg, Uhlenkamp, and Tiefenthaler. Boeckman absent.

Council discussed the fact that the fitness center roof leaks. Estimate have been provided by two contractors and are waiting for a third estimate. Council decided to table the discussion until the October meeting.

Council discussed setting the date for Trick or Treating. It was decided it would be the same as previous years, October 31st from 5:30pm to 7:00pm.

City Clerk Martin have an update on the registration for Iowa Healthiest State walk on October 2, the insurance claim for damage sustained to the lift station pump at the end of July, and discussed an idea of a Christmas Tree lighting ceremony at the time as the Breda Community Club's Old Fashioned Christmas. It was decided Martin would attend the Community Club meeting to discuss possibilities.

Motion to adjourn by Uhlenkamp, seconded by Riesberg at 7:40 PM.
